**ESI EXCELLENCE GLOBAL COMPONENTS:
HALF-YEARLY REVIEW**

The ESI Excellence Global index selects the best rated companies among the largest ones in the world on the basis of Forum Ethibel's ratings and in accordance with the Ethibel Sustainability Indices Guidelines.

On 3 March 2010, the ESI Committee proceeded to the half-yearly review of the Index components.

Withdrawals: 5 components

At each review, the ESI Committee withdraws from the ESI Excellence Global the shares of companies that are no longer listed in the Excellence Ethibel Register and the shares of companies with a free float market capitalisation inferior to 5 billion Euros. Accordingly, the following companies are withdrawn from the index:
